Physical:

Dental history: Four wisdom teeth removed in 2005. First single surface amalgam placed in 2006. Gave birth to my son August 2009. Had 4 more single surface and one double surface amalgams placed in Nov/Dec 2009. I was breast-feeding my son at this time. One single surface amalgam placed Nov 2011. Had all seven amalgams safely removed during two visits in March 2013.

What dental work do you currently have in place? My mouth has been metal free since March 22, 2013.

What dentistry did your mother have at any time before or during pregnancy?

Combination of amalgams, gold crown, and other crown work. I was breast fed.

What vaccinations have you had and when (including flu and especially travel shots)?

Received all normal childhood vaccinations, 1985-1990. 2006 Flu Shot, 2009 swine and flu shot while pregnant, Tetanus shot Nov 2012.
